Please Note

As from May 1 2007, State legislation requires that all new applications to register a dog or cat can not be accepted unless the animal has been implanted with a microchip (proof must be provided). This includes animals moving into the Shire from another Council. However, it does not include animals that were registered with Macedon Ranges Shire Council last year (2006/07).

LOST ANIMALS

Registered animals (wearing tags) will, if possible, be returned home if found wandering.
 If your animal is missing, please phone Customer Service during business hours.
 All impounded animals are held for 8 days only. Pound fees and penalties are applicable to all impounded dogs and cats.
 All unrecovered impounded dogs and cats may be rehoused or destroyed in accordance with Domestic Animals Act.
 Pound releases are by appointment only. Please call 5429 9670 to arrange release fees are payable prior to release.

PRIVACY INFORMATION

The information provided on this form is being collected by Council for the purposes of the Domestic Animals Act and may be used by Council and its contractors for that primary purpose or directly related purposes and may be disclosed as required by law. The applicant may apply to Council for access and/or amendments of the information.

RESTRICTED BREED DOGS

The State Government has introduced laws to restrict the following breed of dogs,

AMERICAN PIT BULL TERRIER, PIT BULL TERRIER, JAPANESE TOSA, DOGO ARGENTINO, FILA BRASILEIRO, PERRO DE PRESA CANARIO

By registering this dog(s), you are declaring that all the information as to the breed of my dog(s) is accurate. Not disclosing the true breed of the dog (if it is a restricted breed dog) may result in Court action or fines being issued.

EXCESS ANIMAL PERMITS

Permits must be obtained to keep more than 2 dogs and 2 cats on land up to

DOCUMENTS YOU MUST SUPPLY TO COUNCIL

For any concession on registration fees, the owner of the animal must produce proof of entitlement.

PENSIONERS

If you are currently the holder of a full eligible pension card, and provide a copy of your pension card, you may be entitled to a 50% reduction in various registration fees.

Note: This does not apply to Healthcare Card holders.

STATE GOVERNMENT LEVY

A State Government levy of \$2.50 per dog and \$1.00 per cat applies to registration. The levy is primarily used by the State Government to fund responsible pet ownership educational programs, which are run by the Bureau of Animal Welfare.

LOST MISPLACED TAGS

The registration tags enclosed are lifetime tags and if lost or misplaced, for any reason, a \$5.00 fee per tag will apply. Owners must apply to Councils' Community Support Unit for each replacement tag.

LIFE TIME TAGS

The numbered tag(s) supplied to you is for the life of this particular animal and cannot be used on any other animal.
 The number, on the tag remains with the animal until you advise the Councils' Community Support Unit of the animal's removal from the municipality, loss or any ownership changes.

 Tags must be worn by your animal at all times.

UNREGISTERED TAGS BEING USED

The owner of an unregistered animal found wearing a Council tag will be issued the State Government penalty applicable plus the relevant registration fee.
