**Responsible Pet Ownership**

- \*Register your dog and cat and ensure they ARE wearing their tags.
- \*Dogs and cats not used for breeding should be desexed.
- \*Confine your animal to your property. Keep your dog on a leash whenever outside the property. Cats should be kept indoors at night.
- \*Remember to "Stoop and Scoop" and clean up after your dog.
- \*Protect the health of your pet by vaccinations, worm control including heartworm for dogs and the control of fleas and ticks. Regular visits to the Vet will help.
- \*Carry out a basic training program with your pet so it is well behaved.
- \*Ensure your pet's diet is well balanced and fresh water is always available.
