## IMPORTANT NOTICE TO DOG & CAT OWNERS

For animals that are sterilised, VCA or FCC registered, over 10 years old or carry an identifying microchip a reduced fee applies. Note: If an animal being registered is sterilised, written proof of sterilisation is required.

**The onus of proof of any of the above is on the applicant. Documentation should be forwarded to support the application. If the animal's particulars have changed from the description on this Registration Notice please indicate and forward the appropriate supporting documents.**

### PRIVACY NOTIFICATION

The personal information requested on this form is being collected by council for the enforcement and administration of animal control in accordance with Section 10 & 18 of the Domestic (Feral and Nuisance) Animals Act 1994. The personal information will be used by Council and its Contractors for that primary purpose or directly related purposes and may be disclosed as required to by law. The applicant may apply to Council for access and/or amendment of the information.

### IMPORTANT NOTICE TO DOG OWNERS:

From the 1st November 2002 amendments to the Domestic (Feral & Nuisance) Animals Act 1994 requires specific controls for the keeping of "RESTRICTED BREEDS" dogs. The Victorian Government has made legislation to restrict the following breeds:

- American Pit Bull Terrier
- Japanese Tosa
- Fila Brasileiro
- Pit Bull Terrier
- Dogo Argentino

**By making payment of this registration, I declare all details on this notice to be true. In particular, the description of the breed of my dog is accurate.**

Failure to declare the breed of your dog if it is one of the restricted breeds above may cause you to be liable to a fine of up to \$511.25, or prosecution in the Magistrates Court.

**The maximum number of dogs/cats that may be kept on any one property is as follows:**

- Less than 2 hectares in area - 2 dogs and 2 cats
  - More than 2 hectares in area - 4 dogs and 4 cats
- Unless a Permit under Local Law No. 6 applies.

**NB: No occupier of property in Halls Gap area (Maps 35, 36 and 37 of the Northern Grampians Shire Planning Scheme) may not keep a cat in their possession from 21 October, 1993 or there after (date of commencement of the Shire of Stawell's Local Law No. 2)**

**\*Cats held in possession in this area, prior to the commencement of the ban, are exempt from the above.**
