IMPORTANT NOTICE TO DOG OWNERS:

From the 1st November 2002, the Domestic (Feral & Nuisance) Animals Act 1994 requires specific control to the keeping of "RESTRICTED BREED DOGS". State Government has made legislation to restrict the following dog breeds:

- AMERICAN PIT BULL TERRIER
- DOGO ARGENTINO
- PIT BULL TERRIER
- FILA BRASILEIRO
- JAPANESE TOSA
- PERRO DE PRESA CANARIO

By making payment of this registration I declare all details on this application to be true. In particular, the description of the breed of my dog as stated below is accurate.

Failure to declare the breed of your dog if it is one of the restricted breeds above may cause you to be liable to a fine of up to \$537, or prosecution in the Magistrates Court.

Important Information

- Under State Laws all cats and dogs aged 3 months and over must be registered.
- **Registration Renewal fees are due and payable by the 10th April each year.**
- **If your dog or cat is eligible for a reduced fee (see reverse side "Fees & Information"). Proof of eligibility is required (either by certificate from the relevant authority or by completing the statutory declaration).**
- **Failure to register may incur a \$537 Penalty.**

- Cheques must be made payable to the "City of Port Phillip".
- **If you pay in person a tag(s) will be issued on the spot by the cashier, if you pay by mail a tag(s) will be posted to you along with your receipt.**
- **Return the completed, entire form with payment.**

Compulsory Microchipping

- **Council must not register a dog or cat that has not been implanted with a microchip after the 1st May 2007; this includes previously registered dogs and cats that move into the council from another council.**
